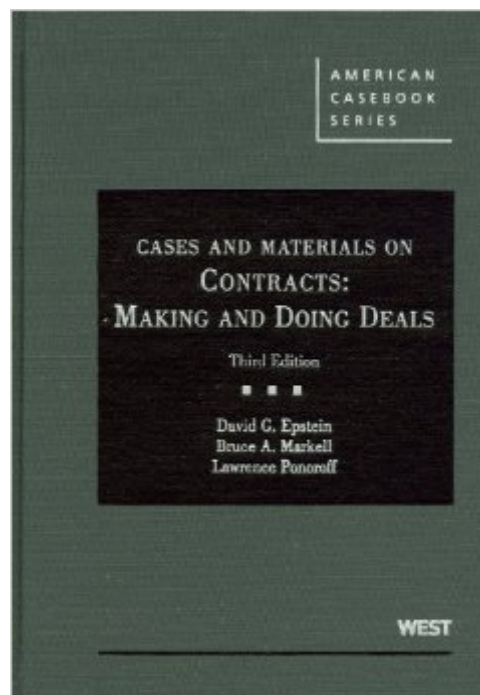

The authors really took the time extra time to make this a fun read. Yes, this casebook is actually entertaining and a pleasure to read. In fact, even if I was not in law school, I might read this book just for the hell of it. If you are assigned this book consider yourself lucky.

The authors have made a very genuine effort to make a complex and dry topic interesting. The case selection is great and the notes and questions tend to be pretty helpful in training you on how to think about the law. I don't know who this review will benefit, seeing as most law students don't get to choose their casebooks. however, if i were a contracts professor choosing a casebook, this would be the one.my only real beef with the textbook is that a significant amount of the questions don't come with answers. Obviously, when you have a professor there to answer them and help you, its fine. But if you're reviewing alone and there's a very difficult hypothetical, the book giving an answer would be much appreciated.

Even though I never actually got the book in the mail [had to buy it at the school book store], the book is pretty funny for a law book. The authors take jabs at each other and include absurd

comments that make the reading assignments more of a fun read than an assignment.

The authors try to inject a little humor into a potentially boring subject. I find that the humor helps me to remember the concepts better, and make it a little less dry.
