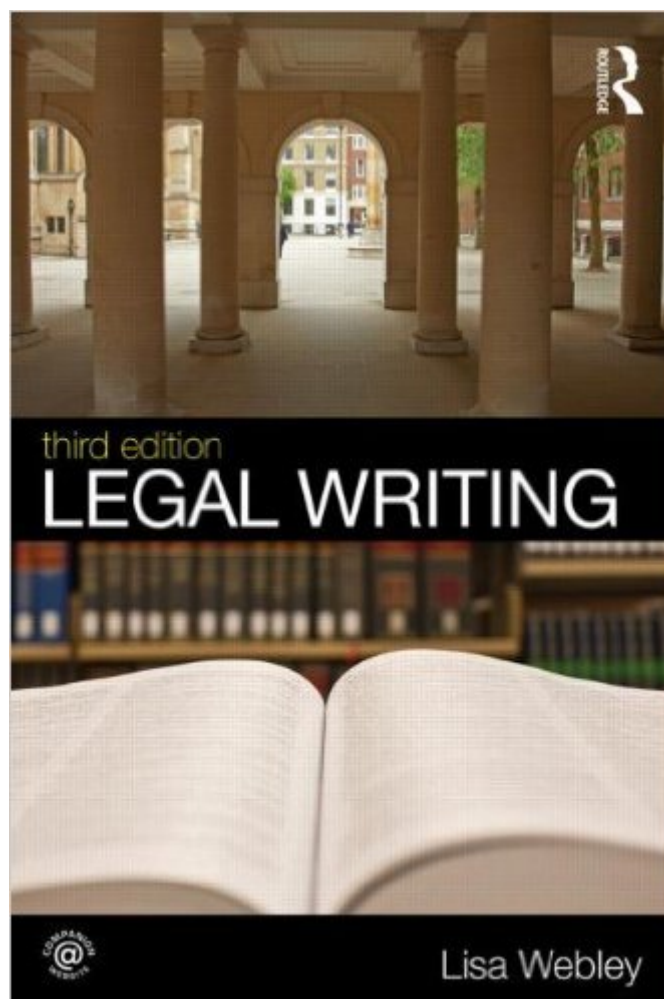

It considers how to deconstruct essay and problem questions and how to conduct and apply legal research to answer set questions.
